Our only official position regarding Bro. Gardner is what we stated in our last letter, "He is not in any contractual relationship or leadership role within Vision Baptist Missions." Though each missionary has the freedom to work out their own personal and ministry relationship with Bro. Gardner through counsel from their own church and pastor, there are no official or unofficial plans by the executive board to have him come back and work with VBM at this time.

As you know, on October 9, VBM was given a letter from Vision Baptist Church stating, "at this time we cannot recommend Austin Gardner for the ministry." Because of this assessment by Vision Baptist Church, it will take some time for Bro. Gardner to prove, as the letter from VBC puts it, "his repentance of sinful patterns in his leadership."

Also, as you know, on October 31, Bro. Gardner changed his membership to a new church, so, according to VBM's own policies, Bro. Gardner would either need to be restored by Vision Baptist or be "a member of an independent Baptist Church that is in agreement with the doctrinal statement of Vision Baptist Missions for at least two years" before he could become a missionary with VBM.

So, as you can see, it is very early days to be making any plans about Bro. Gardner working with VBM again. I would be surprised if he is looking to work with VBM again in an official capacity because he stated in his resignation that he is no longer associated with Vision Missions and will never seek to be again.

I think that all of us hope that eventually there will be reconciliation between him and Vision Baptist Church or at least clear evidence over a period of time that he has repented and changed of those things they found disqualified him from ministry. For something like that to happen, it will probably take quite a bit of time. If that does happen, then perhaps it could be possible for VBM to work with him in some way.

Of course, any decision to work with him officially or to have him begin teaching at the training center or something like that would need to be approved by the executive board of VBM who would want to consult with the pastoral advisory committee as well as the new board of directors that will be set up next year.

So, as far as the executive board of VBM is concerned, it is far too early to be making any plans for him to work at VBM or speculating on what might be done in the future. The main thing for all of us is to focus on is doing the work that Lord has for us and seeking to grow and become more Christlike. I hope that is helpful.

Also, just a quick disclaimer that this response to you is not an official response or statement from the executive board, but I think represents the main issues and thought of the executive board as a whole on this matter. The other guys can clarify anything that I have missed.

Our only official position regarding Bro. Gardner is what we stated in our last letter, "He is not in any contractual relationship or leadership role within Vision Baptist Missions." Though each missionary has the freedom to work out their own personal and ministry relationship with Bro. Gardner through counsel from their own church and pastor, there are no official or unofficial plans by the executive board to have him come back and work with VBM at this time.

As you know, on October 9, VBM was given a letter from Vision Baptist Church stating, "at this time we cannot recommend Austin Gardner for the ministry." Because of this assessment by Vision Baptist Church, it will take some time for Bro. Gardner to prove, as the letter from VBC puts it, "his repentance of sinful patterns in his leadership."

Also, as you know, on October 31, Bro. Gardner changed his membership to a new church, so, according to VBM's own policies, Bro. Gardner would either need to be restored by Vision Baptist or be "a member of an

independent Baptist Church that is in agreement with the doctrinal statement of Vision Baptist Missions for at least two years" before he could become a missionary with VBM.

So, as you can see, it is very early days to be making any plans about Bro. Gardner working with VBM again. I would be surprised if he is looking to work with VBM again in an official capacity because he stated in his resignation that he is no longer associated with Vision Missions and will never seek to be again.

I think that all of us hope that eventually there will be reconciliation between him and Vision Baptist Church or at least clear evidence over a period of time that he has repented and changed of those things they found disqualified him from ministry. For something like that to happen, it will probably take quite a bit of time. If that does happen, then perhaps it could be possible for VBM to work with him in some way.

Of course, any decision to work with him officially or to have him begin teaching at the training center or something like that would need to be approved by the executive board of VBM who would want to consult with the pastoral advisory committee as well as the new board of directors that will be set up next year.

So, as far as the executive board of VBM is concerned, it is far too early to be making any plans for him to work at VBM or speculating on what might be done in the future. The main thing for all of us is to focus on is doing the work that Lord has for us and seeking to grow and become more Christlike. I hope that is helpful.

Also, just a quick disclaimer that this response to you is not an official response or statement from the executive board, but I think represents the main issues and thought of the executive board as a whole on this matter. The other guys can clarify anything that I have missed.

I did not think I would have anything to contribute to this conversation. But there are two areas I think I should respond to for the sake of clarity.

1. I spoke to Steve Moss today. Brendon asked me if Bro Austin had been removed as CEO. I told him yes. I believed it happened in July. When I realized I was wrong I called Steve to communicate to him that I had misunderstood and a deacon forgot to finish paperwork.

He asked me if Bro Austin's name was on other organizational paperwork. I told him not to my knowledge. I told him not on vbm or VBC. I did tell him that OGM was a nonprofit that was never a church ministry that belongs to Bro Austin. He asked if any of our current leadership were on that board. I told him I believed we were all removed. That was my understanding about the plan. I did not mean to mislead him or lead him. He said he would "keep investigating". I guess he did.

2. I do not believe this last statement by Mark Coffey properly represents the standstill we are having in regards to having a working relationship with Bro Austin and Chris. "I know that it will be very difficult for Vbm until his and Trent's relationship is mended or at least on the mend." My personal feelings are not what is causing the separation.

Due to Bro Austin's continual criticism of the leadership of the church and vbm through the restoration process we did not believe he was ready/qualified to go back into his preaching and counseling ministry. On two occasions he has admitted that he was speaking ill of the process. In addition he was not willing to meet with us to discuss his attempts to help those he had hurt find forgiveness.
